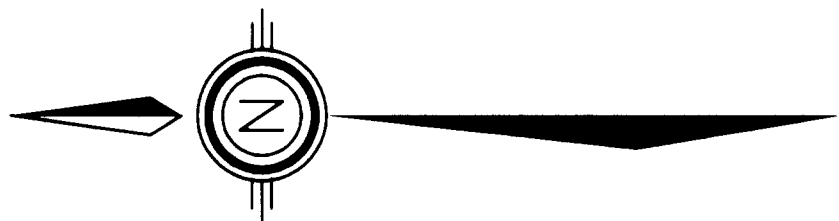


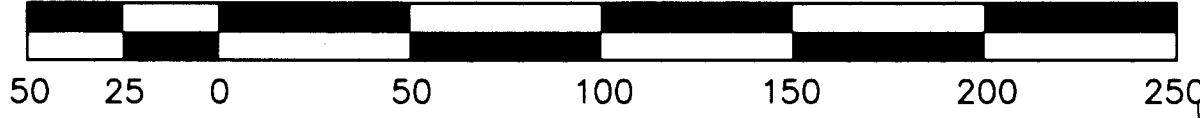
BASIS OF BEARINGS

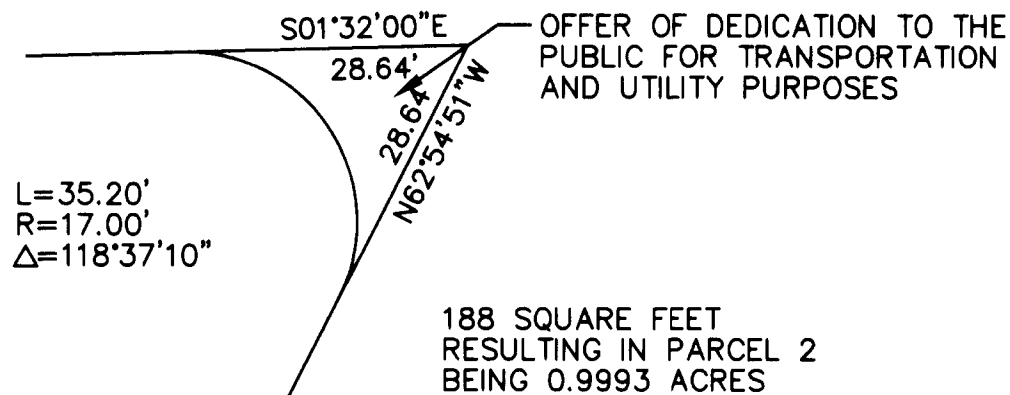

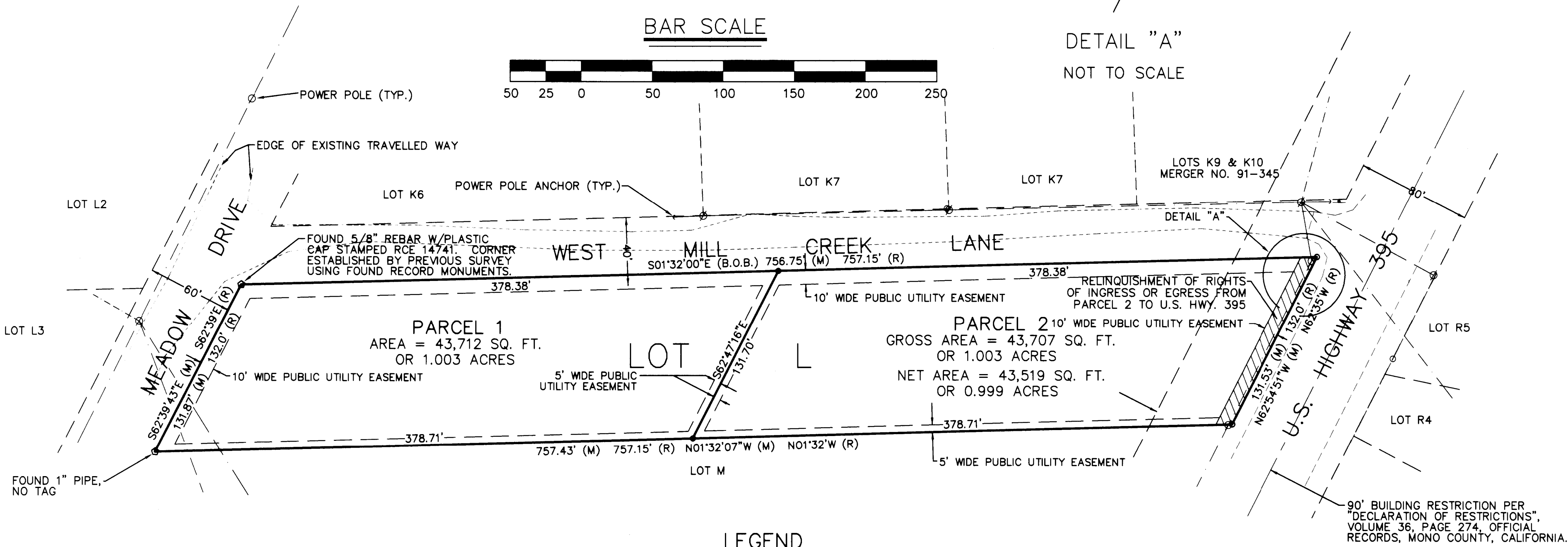
BAR SCALE

MUTUALLY AGREED CLAUSE:

2) PUBLIC UTILITY EASEMENTS ARE HEREBY GRANTED, 10' IN WIDTH COINCIDENT WITH ALL STREET RIGHT-OF-WAY, PRIVATE AND PUBLIC, 5' IN WIDTH COINCIDENT WITH ALL OTHER EXTERIOR BOUNDARIES, AND 10' IN WIDTH CENTERED ON ALL INTERIOR PROPERTY LINES EXCEPTING THAT PORTION OVER EXISTING BUILDINGS.
